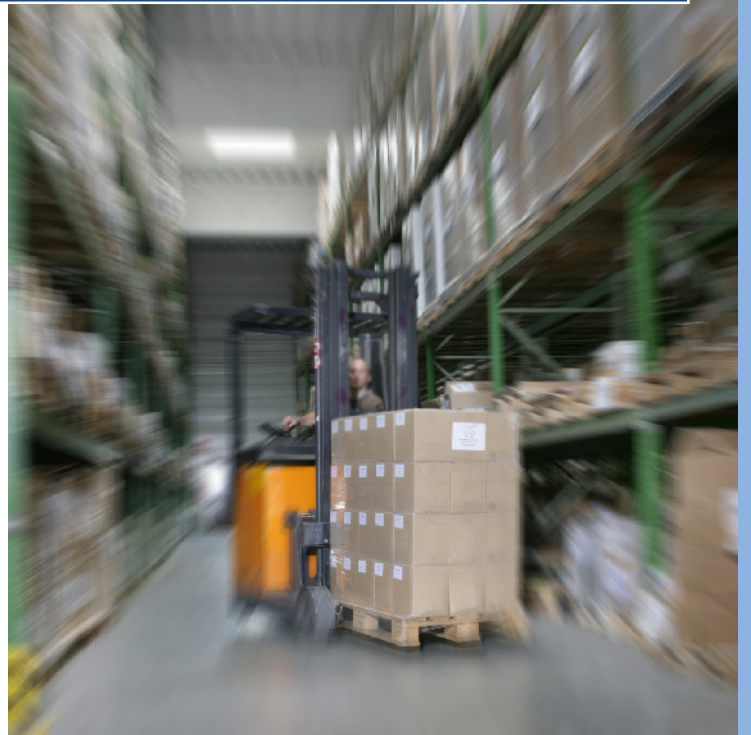

Introduction

The new “Developments and Trends in the Market of Reusable Transport Packaging” study is a general overview, which aims to cover the strategic need for information in the reusable transport packaging sector with substantiated information.

The structure of the study has been developed from this requirement

- n **Market overview**

In the market overview, the top companies of the fundamental industries which use reusable transport packaging are listed by location and turnover. In addition, the production and sales data of selected sectors is added. This section is complemented by an overview of the reusable transport packaging used.

- n **Stock**

The core of the study is an itemisation of the reusable transport packaging stock in Germany and Europe.

- n **Purchasing, turnover ratio and trip costs**

As well as the purchasing costs, the processes for transshipment and pallet handling are described. Examples of circulation speeds and trip costs conclude this segment.

- n **Use of reusable transport packaging**

Across the various pool systems, the profiles (service, locations, management, etc.) of over 30 pool service providers are listed in this chapter over more than 70 pages. This chapter is supplemented by an overview of the service providers for repair, recycling and cleaning (map of washing plants).

- n **Developments in the reusable transport packaging sector**

Product developments, developments in warehousing and the presentation of goods.

- n **Freight transportation and reusable transport packaging**

Freight transportation volumes, prognosis of freight transport volume and developments in reusable transport packaging relating to freight transportation; influencing factors and volume reduction are the essential components of this chapter.

- n **Guidelines and standards**

Hygiene, HAACP, IFS, REACH, ISPM, RFID EPCglobal and other regulations are the foundation of this chapter.

- n **Management systems**
